General Terms and Conditions

The contents of the Member User Manual and the terms and conditions set out below are important and affect your rights as a member of Pharadigm. Together they form your Membership Agreement and you should read them carefully.

This document **replaces any previous documents** and shall prevail notwithstanding any publicity material published of any nature whatsoever.

1. Pharadigm reserves the **right to change these rules and regulations** at any time.
2. Pharadigm reserves the right to terminate the Programme by giving three months' notice. This means that a member's right can be terminated three months after Pharadigm Option notifies the member.
3. Programme rules, regulations, (as per Pharadigm Member User Manual) rewards and special offers are subject to change without notice.

Definitions

4. "Benefits" – means any preferential rate, discounted rate etc. that is arranged by the Programme for members of the Programme.
5. "Contact Centre" is a central contact point for enquiries, registration, complaints and suggestions from and to Members of the Programme.
6. "Member" – means a member of the Programme.
7. "Active Member" - means a paid up member who has paid an activation fee where applicable for a certain benefit.
8. "Partner" – means any person, organization, company of any nature that contributes, provides services, benefits and facilities to members of the Programme.
9. "Programme" – means the Pharadigm lifestyle enhancement programme of Sweidan Trust (Proprietary) Limited Registration number 1992/002840/07.

Membership Eligibility

10. Membership is open to all members of medical schemes administered by Private Health Administrators or medical schemes that may have been contracted to or outside of Private Health Administrators.
11. Enrolment must be in the applicant's full legal name. Only one enrolment per person will be accepted.
12. Change of address and / or name change on the member's record will be accepted only if they are notified to the Programme in writing. Proof of name change may be required.

General

13. If any benefits, services, facilities or arrangements are made available to the member as a result of his / her membership, whether these are provided by the Programme or a Partner, such a member will be personally liable for any and all costs, taxes, charges, claims or liabilities of whatever nature arising from the provision or availability of such benefits, facilities or arrangements.
14. The Programme reserves the right at any time in its absolute discretion and without giving notice to refuse Membership, to revoke Membership or to refuse or withdraw Membership.
15. If the member wishes, he / she may terminate his / her membership by giving 2 calendar months notice in writing, on an official Pharadigm Termination of Membership form which is obtainable from the Pharadigm Contact Centre on telephone number 0860 BE WELL / 0860-23 9355 and must be mailed to: Pharadigm Administration PO BOX 343 WESTVILLE 3630 or faxed to Pharadigm Administration on 031-267 5169.
16. While Pharadigm will use its reasonable endeavors to ensure that the services, benefits, facilities and arrangements expressed or advertised as being available to members from Partners will be available, the Programme does not guarantee or warrant that such services, benefits, facilities or arrangements will be available and the Programme will not be liable for any loss or damage, whether direct or indirect, arising from the provision or non-provision, whether in whole or part, of any such services, benefits, facilities or arrangements.
17. When a member seeks to use or obtain any of the services, benefits, facilities or arrangements offered to Members, the provision of such services, benefits, facilities or arrangements will be subject in each case to the Terms and Conditions of the provider of said, benefits, facilities or arrangements.
18. These Terms and Conditions do not constitute or create a members or proprietary club.
19. South African law governs these Terms and Conditions. In the event of any dispute both parties agree to submit to the exclusive jurisdiction of the South African courts.
20. The Member agrees that by signing his / her membership application forms that he / she has read and understood the Terms and Conditions of the Pharadigm Lifestyle Enhancement Programme and confirms that he / she accepts them and is eligible for membership.
21. By signing his / her membership application, a Member consents to the Programme, maintaining and updating data that is personal to the member.  23. All consent given by the member shall be deemed to continue until withdrawal of such consent, by giving 2 calendar months notice, received in writing, by Pharadigm Administration at PO BOX 343 WESTVILLE 3630 or via fax at 031-267 5169.
 24. Pharadigm may at any time, without giving notice, change the Pharadigm Benefit structure by revising particular benefits, nominate an unlimited number of restrictions, limit the availability of fares at preferential rates to any or all destinations and introduce and review membership fees.
 25. A Member shall be deemed to have agreed to any of the changes described above if the Programme has sent him / her notice of such changes. If the Member does not accept these changes he / she may terminate his / her membership in the manner as described in this document.
 26.
